Today, gubernatorial candidate Ron Sparks traveled across the state to confirm his full and continued commitment to the governor's race.

"I am in this governor's race, and I am in this race to win", said Sparks.

On December 22, 2009 Congressman Parker Griffith announced that he was changing parties. From the time of Griffith's announcement, Commissioner Ron Sparks received calls from members of Congress asking him to strongly consider a run for the 5th District of Alabama because they believed that he was the strongest democratic candidate. While Commissioner Sparks said it would be an honor to represent the people of the 5th Congressional District, he remained dedicated to his path to become Alabama's next governor.

"Parker Griffith abandoned the Democratic party as well as his constituents in Alabama's 5th Congressional District whose support allowed him to take office," Sparks said.

While confirming his intentions to seek the office of governor, Sparks said his democratic opponent in the governor's race has turned his back on the people who sent him to Congress, much as Parker Griffith has turned his back on the people of the 5th Congressional District.

"When Artur Davis had the opportunity to vote for the people of Alabama or the big credit card companies, he chose the credit card companies. When Artur Davis had the chance to help the people of his district and across Alabama gain access to affordable healthcare, he voted against it," Spark said.

Sparks also emphasized that Davis had criticized Sparks' plan to regulate and tax gambling to help fund Medicaid and public schools.

"I am the only candidate of either party that has a real plan to meet the financial crisis ahead of us and Davis does nothing but criticize. And when I offered an education lottery proposal to help build the foundation of our state's future, he ridiculed the idea, Sparks said. "Artur Davis just keeps throwing bricks while I'm trying to build our future."

Sparks pointed to the Davis plan to support charter schools as a clear example of wrong thinking for the people of Alabama.

"Artur Davis wants to take money away from our public schools and give it to private schools. At a time when we are laying off teachers and cutting school programs, this concept is insane," Sparks said.

Sparks emphasized that Davis is raising hundreds of thousands of dollars from out-of-state drug companies and big businesses while the Sparks campaign is Alabama based.

"Artur Davis is raising hundreds of thousands of dollars with fundraising events in Manhattan penthouses while our support comes from main street Alabama. That's why I am in this race to stay and that is why we will win," Sparks said.
